Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 35 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 19th December 2016 and may be cited as "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 5 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014"

"Amendment Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 5 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

to Schedule 1 – Off Street Parking Places



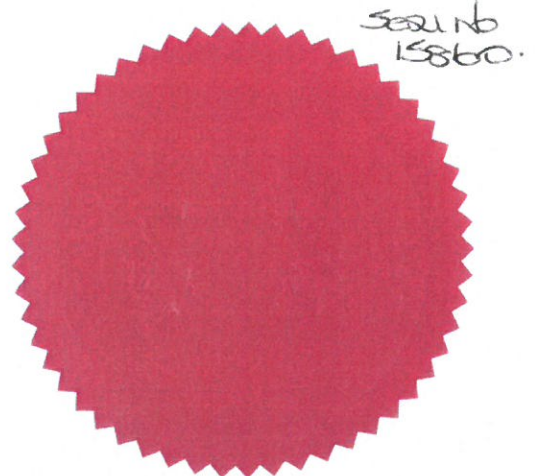
