Coming into Force: 1st April March 2019

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 1st April 2019 and may be cited as "Northumberland County Council North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011 - Amendment No 32 Order 2019".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011- Amendment No 32 Order 2019".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:



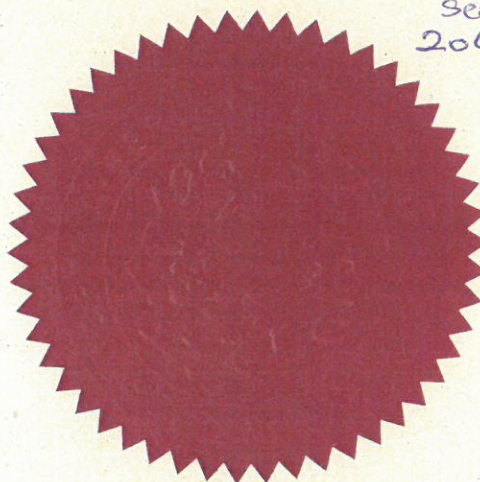

(WAITING AND LOADING – Ref TRO_003_32):- NOTICE IS HEREBY GIVEN that the Northumberland County Council have made the above-named Order under Sections 1, 2, 4 and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into force on the 1st April 2019 will be to introduce parking restrictions to alleviate inconsiderate parking around on both Clayport Street and Canongate in Alnwick in the County of Northumberland.

The following restrictions are added to the Principal Order, North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011 (TRO_003):-

Addition – Waiting – Proscribed – At Any Time

Exemptions for certain necessary purposes are included in the Order.

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to the Order you may before the 10th May 2019 apply to the High Court for that purpose.
