West Road Area Belford

The Order is necessary to improve road safety on West Road, to allow great visibility when exiting from adjacent junctions, by introducing a Waiting and Loading restriction (Double Yellow Lines). This will also compliment the recently introduced 20 MPH Speed Limit on West Road Belford
