STATEMENT OF THE COUNCILS REASONS FOR MAKING THE ORDER

The general effect of this Order will be to introduce: - No Waiting At Any Time parking restrictions (double yellow lines) in a small number of areas in Beadnell Village on a permanent basis.

These restrictions will be made permanent on sections of the highway on Benthall, Longbeach Drive, Dunes Court, The Haven and The Wynding, Beadnell Village, this follows an Experimental Order which has been in place for the past twelve months.
