STATEMENT OF THE COUNCILS REASONS FOR MAKING THE ORDER

This Order has been considered necessary to alleviate road safety issues adjacent to Shaftoe Trust First School Haydon Bridge.

These issues are as a result of parked cars adjacent to the school, at predominately school opening times. It is proposed to extend the existing keep clear road markings (yellow zigzag lines) on Langley Road and introduce No Waiting restrictions (double Yellow Lines) on Langley Road and The Showfield junction.
