1. Commencement and Citation

"Amendment Order" means "Northumberland County Council West Northumberland Area (Parking Places) Composite Order 2011- Amendment No 27 Order 2020".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
