1. Commencement and Citation

This Order shall come into operation on the 30 September 2019 and may be cited as "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 32 Order 2019".

"Amendment Order" means "Northumberland County Council North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 32 Order 2019".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

Morpeth First School
