Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

Commencement and Citation

This Order shall come into operation on the 1st December 2016 and may be cited as "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011 - Amendment No 19 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011".

"Amendment Order" means "NCC South East Northumberland Area (Parking Places) Composite Order 2011 - Amendment Order No 19 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDERS

The general effect of the above Orders will be to make permanent the Experimental Orders in accordance with Regulation 23, "The Local Authorities" Traffic Orders (Procedure) (England & Wales) Regulations 1996.

The Experimental Orders ran from the 1st December 2015 to the 30th November 2016 (ref TRO_011_30 and TRO_012_12). Following this trial period and ongoing consultation with residents and road users it has been decided to make the above Orders permanent.

The above Orders will make permanent a Resident Parking Zone in Westloch Road Cramlington together with associated No Waiting at Any Time Restrictions in the Cragside area of Cramlington.
