### 1. Commencement and Citation

This Order shall come into operation on the 14<sup>th</sup> December 2020 and may be cited as "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011 - Amendment No 32 Order 2020".

#### 2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011- Amendment No 32 Order 2020".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
