NORWICH CITY COUNCIL (UNIVERSITY AREA CONTROLLED PARKING ZONE) AMENDMENT TRAFFIC REGULATION ORDER 2018

The City Council of Norwich pursuant to an agency agreement entered into under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2, and 4 and the powers contained in Sections 32 and 35 of the Road Traffic Regulation Act 1984 and all other enabling powers and with the consent of the Norfolk County Council given under Section 39(4) of the Road Traffic Regulation Act 1984 and all other enabling provisions of the Road Traffic Regulations Act 1984, hereby makes the following Order: -

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (University Area Controlled Parking Zone) Amendment Traffic Regulation Order 2018 and shall come into effect for all purposes on 3rd September 2018.

- 2. The Norwich City Council University Area Parking Zone Traffic Regulation Order 2004 as amended (hereinafter referred to as the "2004 Order") is amended as set out in Articles 4 to 14 below.
- 3. The Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 is amended as specified in Article 15 of this Order.
- 4. Schedule 1 is amended as specified in Schedule 1 of this Order.
- 5. Schedule 4 is amended as specified in Schedule 2 of this Order.
- 6. Schedule 16 is amended as specified in Schedule 3 of this Order.
- 7. Schedule 74 is amended as specified in schedule 4 of this Order.
- 8. Schedule 94 is amended as specified in Schedule 5 of this Order.
- 9. Schedule 97 is amended as specified in Schedule 6 of this Order.
- 10. Schedule 108 is amended as specified in Schedule 7 of this Order.
- 11. Schedule 115 is amended as specified in Schedule 8 of this Order.
- 12. The definition of 'operational date' is amended for properties within the streets (or parts of streets) described in Schedule 1 for which the operational date is the date this Order came into effect.
- 13. The following paragraph is added as Article 3(8):-
 - "3(8) Insofar as any provision of this Order conflicts with the effect of markings placed on the carriageway, "Any Bus Stop Clearway

specified in Schedule 16 or Schedule 72 is installed under Schedule 7, Part 6, paragraphs 1 and 4 of the Traffic Signs Regulations and General Directions 2016 conveying the existence of a bus stop clearway the effect of the clearway shall prevail."

- 14. The following is paragraph is added as article 4(5):-
 - "4(5) Any Bus Stop Clearway specified in Schedule 16 or Schedule 72 is installed under Schedule 7, Part 6, paragraphs 1 and 4 of the Traffic Signs Regulations and General Directions 2016 conveying the existence of a bus stop clearway."
- 15. All references to those streets (or part of streets) referred to in Schedule 1 are deleted from the Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 (as amended).
- 16. Insofar as any provision of any previous Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.
