(CITY CENTRE CONTROLLED PARKING ZONE AMENDMENT NO. 1)

TRAFFIC REGULATION ORDER 2001

The Norwich City Council pursuant to an agency arrangement under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of that County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order:-

1. Citation and Commencement

This Order may be sited as the Norwich City Council (City Centre Controlled Parking Zone Amendment No. 1) Traffic Regulation Order 2001 and shall come into effect for all purposes on the 10 bl. October 2001.

The Norwich City Council (City Centre Controlled Parking Zone) (No. 1) Traffic Regulation Order 2000 is amended as follows:

- (a) The following definition is added:
 - "Coach" means a vehicle with 12 or more seats excluding the driver.
- (b) Reference to Theatre Street and to the southwest side of Rampant Horse Street between its junctions with Theatre Street and Malthouse Road are deleted from Schedules 15, 16, 30, 31 and 45 of the Norwich City Council (City Centre Controlled Parking Zone) (No. 1) Traffic Regulation Order 2000.
- (c) The schedules to this Order numbered 15, 16, 27, 30 and 54 are added to the schedules of the Norwich City Council (City Centre Controlled Parking Zone) (No. 1) Traffic Regulation Order 2000.
- (d) The following Articles are added to the Norwich City Council (City Centre Controlled Parking Zone) (No. 1) Traffic Regulation Order 2000:
 - Article 10 Nothing in the Articles to this Order shall prevent a person causing or permitting a vehicle to wait in Theatre Street if that vehicle is waiting for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
 - Article 11 No person shall cause or permit any vehicle other than a coach to wait in the lengths of road specified in Schedule 54 to this Order. No person shall cause or permit a coach waiting in the lengths of road specified in Schedule 54 of this Order to wait for longer than a period of 30 minutes continuous waiting and shall not cause a vehicle to return to any of the lengths of road specified in Schedule 54 of this Order within one hour of the ending of a previous period of waiting in any length of road specified in Schedule 54 of this Order.
