THE CITY OF NORWICH

(RESIDENTS CAR PARKS) ORDER 2001

The Norwich City Council in exercise of the powers contained in Sections 32 and 35 of the Road Traffic Regulation Act 1984 and all other enabling powers and with the consent of the Norfolk County Council given under Section 39(4) of the Road Traffic Regulation Act 1984 hereby make the following order:-

Commencement and Citation

- 1. This order shall be cited as "The City of Norwich (Residents Car Parks) Order 2001" and shall come into effect for all purposes on the 21 December 2001.
- 2. The City of Norwich (Residents Car Parks) Order 1996 as amended by the City of Norwich (Residents Car Parks) Order 1998 is amended as follows:-

The following is added to article 5

and other than Hanover Road, which is permit controlled between Monday to Saturday, 8.00 a.m. to 6.30 p.m., excluding Bank Holidays which are not permit controlled.

- 3. Article 42 is renumbered 42A and the following articles 42B, 42C and 42D inserted before Article 43:-
 - A person holding a residents parking permit, community carers parking permit or residents visitors parking permit for sub zone S of the south-western controlled parking zone issued under the provisions of the Norwich City Council South-Western Controlled Parking Zone Traffic Regulation Order 1996 as amended may use that residents parking permit to park a vehicle of which they are the owner or main keeper in Hanover Road car park.
 - 42C A person holding a residents parking permit, community carers parking permit or residents visitors parking permit for sub zone T of the south-western controlled parking zone issued under the provisions of the Norwich City Council South-Western Controlled Parking Zone Traffic Regulation Order 1996 may use that permit to park a vehicle of which they are the owner or main keeper in the car park known as 58/134 Newmarket Street (rear access road).
 - A person holding a residents parking permit, community carers parking permit or residents visitors parking permit for sub zone N of the western controlled parking zone issued under the provisions of the Norwich City Council Western Controlled Parking Zone Traffic Regulation Order 1997 may use that permit to park a vehicle of which they are the owner or main keeper within the Belvoir Street car park.
- 4. The schedule to this order is added to the schedule of the City of Norwich (Residents Car Parks) Order 1996.
