CANARY WAY AMENDMENT  
TRAFFIC REGULATION ORDER 1999

The Norwich City Council, pursuant to an agency arrangement entered into under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of that County Council under Sections 1, 2 and 4 and all other enabling provisions of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police, hereby make the following Order:

Citation and Commencement

1. This Order may be cited as the "The Norwich City Council (Eastern Controlled Parking Zone) Canary Way Amendment Traffic Regulation Order 1999" and shall come into effect for all purposes on the 6<sup>th</sup> day of December 1999.

Amendment

2. The Norwich City Council (Eastern Controlled Parking Zone) Traffic Regulation Order 1999 is amended as follows:

In Article 1(4) "permit holder's parking place" is amended to read as follows - means a road or part of a road specified in schedules 3 or 4 to this Order.

3. Reference in Articles 5, 21, 24, 27 and 30 to Schedule 3 is amended to read as follows - Schedules 3 and 4.

4. Article 9(d) is amended as follows:

If a permit holder's parking place is marked with lines delineating parking spaces no person shall cause or permit a vehicle to stand other than within the markings of a single space.

5. Schedule 1 is amended by the addition of the following:

Roads or Lengths of Roads within the Controlled Parking Zone	Properties for the purposes of issuing Parking Permits	Sub-Zone	Prescribed Hours
Canary Way (from its junction with Carrow Road) for a distance of 25 metres		A	At any time
The area of carriageway outside nos.49-69 Carrow Road, titled "Carrow Road Cul-de-Sac	Carrow Road Nos.20-58 (even) Nos.35-103 (odd) Prospect Terrace	A	At any time

5. Schedule 4 is amended by the addition of the following:

Carrow Road Cul-de-Sac (south east side) Zone A -  
from a point level with the common boundary of nos.53  
and 55 Carrow Road to a point 1 metre south west of  
the common boundary of nos.69 and 71 Carrow Road.

Carrow Road Cul-de-Sac (north west side) Zone A -  
from a point opposite 2 metres south west of the  
north eastern flank wall of no.55 Carrow Road to a  
point 1 metre north east of that flank wall.

Carrow Road Cul-de-Sac (north west side) Zone A -  
from a point opposite 3 metres north east of the  
north eastern flank wall of no.55 Carrow Road to a  
point 1 metre south west of the common boundary of  
nos.69 and 71 Carrow Road.
