

NORWICH CITY COUNCIL
(SOUTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING)
(Earlham West Centre) TRAFFIC REGULATION ORDER 2004

The City Council of Norwich, pursuant to an agency arrangement entered into with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order:

Citation and Commencement

1. This Order may be cited as The City of Norwich (Southern Area) (Prohibition and Restriction of Waiting) (Earlham West Centre) Traffic Regulation Order 2004 and shall come into effect for all purposes on 16th July 2004.
2. Schedule 1 of The City of Norwich (Southern Area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 is amended by the inclusion of the roads and part roads as detailed in the Schedule to this Order.

SCHEDULE

Schedule 1 No Waiting At Any Time

Earlham West Centre

- (i) the outer side from a point 6 metres north of the southern boundary of number 30 Earlham West Centre, in a clockwise direction, to a point 3 metres east of the north-eastern back of highway line of Enfield Road
- (ii) the outer side from a point 4 metres south of the northern boundary of number 10 Earlham West Centre, in an anti-clockwise direction to a point 3 metres south-east of the south-eastern back of highway line of Rockingham Road

Earlham West Centre Service Road

- (i) both sides from its junction with Enfield Road to a point 5 metres south-west of the south-western back of highway line of Enfield Road

Edgeworth Road

- (i) both sides from its junction with Rockingham Road to a point 5 metres south-east of the south-eastern back of highway line of Rockingham Road

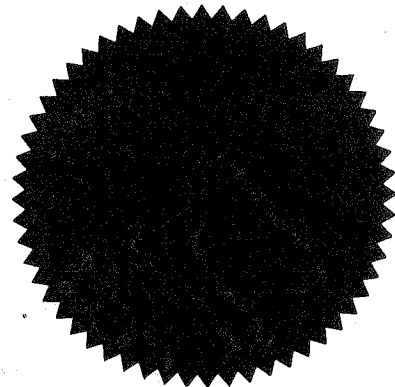
Enfield Road

- (i) the north-east side from a point opposite and 2 metres north-west of the boundary of numbers 1/3 Enfield Road to its junction with Earlham West Centre
- (ii) the south-west side from a point 5 metres south-east of the boundary of numbers 1/3 Enfield Road to a point 20 metres south-east of the boundary of numbers 1/3 Enfield Road
- (iii) the south-west side from its junction with Earlham West Centre to a point 50 metres south-east of the boundary of numbers 1/3 Enfield Road

Rockingham Road

- (i) both sides from a point 48 metres north-east of the boundary of numbers 2/4 Rockingham Road to its junction with Earlham West Centre
- (ii) the north-west side from a point 3 metres north-east of the boundary of numbers 2/4 Rockingham Road from a point 20 metres north-east of the boundary of numbers 2/4 Rockingham Road
- (iii) the south-east side from a point opposite and 3 metres north-east of the boundary of numbers 2/4 Rockingham Road to a point opposite and 38 metres north-east of the boundary of numbers 2/4 Rockingham Road
