

NORWICH CITY COUNCIL (SOUTHERN AREA)
(PROHIBITION AND RESTRICTION OF WAITING)
(GLEBE ROAD, SANDRINGHAM ROAD, STAFFORD STREET
AND ST PHILIPS ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2005

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2, and 4, of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. **Citation and Commencement**

This Order may be cited as the “Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) (Glebe Road, Sandringham Road, Stafford Street and St Philips Road) Amendment Traffic Regulation Order 2005” and shall come into effect for all purposes on the 12th day of December 2005.

2. Schedule 1 of The Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) (Consolidation) Traffic Regulation Order 1982 (as amended) is amended by the addition of references to Sandringham Road, Stafford Street and St Philips Road and the amendment of references to Glebe Road as set out in the Schedule to this Order.

SCHEDULE

Schedule No 1 **No Waiting At Any Time**

Glebe Road – Amendment

Delete the following references

- (i) both sides from its junction with Unthank Road to a point 10 metres north-west of the north-western back of highway line of Unthank Road
- (ii) the east side from the boundary of Nos. 3/5 Glebe Road for a distance of 20 metres in a south-easterly direction

Insert the following references

- (i) both sides from its junction with Unthank Road to a point 9 metres north-west of the north-western back of highway line of Unthank Road
- (ii) the north-east side from the boundary of Nos. 3/5 Glebe Road for a distance of 21 metres in a south-easterly direction

Sandringham Road – New Provision

- (i) the north side from a point 5 metres west of the western back of highway line of St Philips Road to a point opposite the boundary of Nos. 13/15 Sandringham Road

- (ii) the south side from the boundary of Nos. 13/15 Sandringham Road for a distance of 1 metre in a westerly direction

Stafford Street – New Provision

- (i) the south side from a point opposite the western boundary of No. 26 Stafford Street for a distance of 1 metres in a westerly direction

St Philips Road – New Provision

- (i) both sides from its junction with Sandringham Road to a point 5 metres north of the northern back of highway line of Sandringham Road
