

THE CITY OF NORWICH (NORTHERN AND SOUTHERN)

WAITING CONSOLIDATION AMENDMENT

TRAFFIC REGULATION ORDER 2001

The Norwich City Council pursuant to an arrangement entered into under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 and all other enabling provisions of the Road Traffic Regulation Act 1984 after consultation with the Chief Officer of Police hereby makes the following Order:-

Citation and Commencement

1. This Order may be sited as the City of Norwich (Northern and Southern) Waiting Consultation Amendment Traffic Regulation Order 2001 which shall come into effect for all purposes on 23rd July 2001.
2. The Norwich City Council (Northern area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 is amended in respect of Schedules 1 and 3 by the introduction of Waiting Restrictions in accordance with the new provisions and additions mentioned in Schedules 1 and 3 to this Order marked "Northern Area".
3. The Norwich City Council (Northern area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 is amended in respect of Schedule 7 by the deletion of reference to Catton Grove Road, east side, and the introduction of the reference to Catton Grove Road, east side, contained in Schedule 7 to this Order marked "Northern Area".
4. The Norwich City Council (Southern area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 is amended in respect of Schedule 1 by the introduction of the Waiting Restrictions mentioned as new provisions and additions in Schedule 1 of this Order headed "Southern Area".
5. The City of Norwich (Southern area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 is amended in respect of Schedule 6 by the deletion of previous reference to Bessemer Road, North/West side, and Bessemer Road, South/East side by the deletion of the current reference and the addition of the Waiting Restrictions in respect of those areas of Bessemer Road mentioned in Schedule 6 to this Order.

Revocations

6. The ~~Trunk Road~~ (Carrow Road, Norwich) (One Way Traffic, Prohibition and Restriction of Waiting) Order 1986 Sections 2, 3 and 4 are revoked.

No Waiting At Any Time

Alfred Nicholls Court

New provision.

Both Sides

From its junction with Rackham Road to a point in line with the western boundary line of No.1 Alfred Nicholls Court.

Anthony Drive

New provision

Both Sides

From its junction with Sprowston Road to a point 10m East of the eastern back of the highway line of Sprowston Road.

Ash Grove

New provision.

Both Sides

From its junction with Constitution Hill to a point 10m east of the eastern back of the highway line of Constitution Hill.

Beech Drive

Addition

West Side

From it's southern highway line in a northern direction for 5m.

From a point 13m north of it's southern highway line in a northerly direction for 22m

From a point 56m north of it's southern highway line in a northerly direction for 24m.

East Side

From it's junction with Renson Close to it's southern cul-de-sac end.

South Side

For the entire length of the cul-de-sac end.

<u>Bignold Road</u>	Addition
Both Sides	From a point in line with the boundary line between Nos. 27 and 29 Bignold Road to a point 1.5m south of the boundary line between Nos. 20 and 22 Bignold Road.
<u>Britannia Road</u>	Addition.
West Side	From a point 10m north of the northern back of the highway line of Plumstead Road to a point 10m south of the southern back of the highway line of Ketts Hill.
East Side	From a point 10m north of the northern back of the highway line of Vincent Road to a point 10m south of the southern back of the highway line of Vincent Road.
<u>Britannia Road</u> Cont/...	
East Side	From a point 10m north of the northern back of the highway line of Plumstead Road to a point 8m south of the southern back of the highway line of Plumstead Road.
<u>Cannell Green</u>	New provision
South Side	From a point 1m west of the west building line of flat Nos. 16 and 19 Cannell Green in an easterly direction for 4m.
<u>Carrow Road</u>	New provision
South East Side	From its junction with Thorpe Road to a point 30m south-west of the southern back of the highway line of Thorpe Road.
<u>Churchill Road</u>	Addition
South Side	From a point in line with the eastern property line of No.39 Churchill Road in an easterly direction for 11m.

Constitution Hill

East Side

Addition

From its junction with Ash Grove to a point 10m south of the southern back of the highway line of Ash Grove.

Cotman Road

South/East Side

Addition.

From a point 5m north-east of the north/eastern back of the highway line of Fern Hill in a south-westerly direction for 23m.

Cremorne Lane

Both Sides

New provision

From its junction with Thorpe Road in a southerly direction to a point 8m south of the southern back of the highway line of Thorpe Road when measured next to No.81 Thorpe Road.

Curtis Road

West Side

Addition

From a point in line with the northern boundary line of No.2 Curtis Road in a northerly direction for 10m.

Deloney Road

Both Sides

New provision

From its junction with Salhouse Road in a southerly direction to a point 15m south of the southern back of the highway line of Salhouse Road.

Drayton Road

South-west Side

Addition

From a point in line with 6m west of the western boundary line of No.141 Drayton Road to a point in line with the eastern boundary line of No. 88 Drayton Road.

North-east Side

From a point 10m west of the western back of the highway line of Junction Road to a point 10m east of the eastern back of the highway line of Junction Road.

<u>Fern Hill</u>	New provision.
Both Sides	From its junction with Cotman Road in a south-westerly direction for 2m.
<u>Havers Road</u>	New provision
North Side	From its junction with Drayton Road to a point 55m east of the eastern boundary line of No.2 Havers Road.
South Side	From its junction with Drayton Road to a point 74m east of the eastern boundary line of No.2 Havers Road.
<u>Hooper Lane</u>	New provision
Both Sides	From its junction with Sprowston Road to a point 10m east of the easterly back of the highway line of Sprowston Road.
<u>Junction Road</u>	Addition
Both Sides	From its junction with Drayton Road to a point 10m north of the northern back of the highway line of Drayton Road.
<u>Ketts Hill</u>	Addition.
Both Sides	From a point in line with the boundary line between 50 Britannia Road and 148 Ketts Hill to its junction with Britannia Road.
<u>Lawson Road</u>	New provision
South Side	From a point in line with the eastern boundary line of No.58 Lawson Road to a point in line with the boundary line between Nos.68 and 70 Lawson Road. Including both sides of the service road between these points for a length of 14m measured from the southern back of the highwayline of Lawson Road.

<u>Matlock Road</u>	New provision
Both Sides	From its junction with Thorpe Road to a point 10m north of the northern back of the highway line of Thorpe Road.
<u>Paine Road</u>	New provision
Both Sides	From its junction with Witard Road to a point 17m west of the western back of the highway line of Witard Road.
<u>Plumstead Road</u>	Addition.
Both Sides	From its junction with Britannia Road to a point in line with the boundary between 65 Britannia Road and 26 Plumstead
Road.	
<u>Primrose Road</u>	Addition.
Both Sides	From its junction with Telegraph Lane East to a point 5m south-west of the south-western back of the highway line of Telegraph Lane East.
<u>Rackham Road</u>	New provision
Both Sides	From a point 7m north of the northern boundary line of No.71 Rackham Road in a northerly direction for 18m.
<u>Renson Close</u>	Addition
South side	From its junction with Beech Drive to a point 8m east of the eastern back of the highway line of Beech Drive.
<u>Roseville Close</u>	New provision
Both Sides	From its junction with Thorpe Road to a point 12m south of the southern back of the highway line of Thorpe Road.

Sale Road

New provision

North Side

From its junction with Watling Road to a point 13m north-east of the eastern back of the highway line of Watling Road.

South Side

From its junction with Watling Road to a point 18m north-east of the eastern back of the highway line of Watling Road.

Salhouse Road

Addition

South-east Side

From a point 6m east of the eastern back of the highway line of Deloney Road to a point 15m west of the western back of the highway line of Deloney Road.

From a point in line with the boundary line between Nos. 102 and 104 Salhouse Road in a westerly direction to a point in line with the boundary line between Nos.76 and 78 Salhouse Road.

Salisbury Road

New provision

Both Sides

From its junction with Thorpe Road to a point 5m south of the southern back of the highway line of Thorpe Road.

Sprowston Road

Addition

South-east Side

From a point 10m south of the south-western back of the highway line of Hooper Lane to a point 10m north of the north-eastern back of the highway line of Hooper Lane.

From a point 10m south of the south-western back of the highway line of Anthony Drive to a point 10m north of the north-eastern back of the highway line of Anthony Drive.

Telegraph Lane East

South/West Side

Addition.

From a point 10m north of the northern back of the highway line of Primrose Road to a point 10m south of the southern back of the highway line of Primrose Road.

Thorpe Road

North Side

Addition

From a point 7m west of the western back of the highway line of Heathside Road to a point 7m east of the eastern back of the highway line of Heathside.

From a point 7m west of the western back of the highway line of Matlock Road to a point 8m east of the eastern back of the highway line of Matlock Road.

South Side

From its junction with Carrow Road to its junction with Salisbury Road.

From a point 6m east of the boundary line between Nos.99 and 101 Thorpe Road to a point 10m east of the easterly back of the highway line of Roseville Close.

Valpy Avenue

Both Sides

Addition

From a point 5m east of the eastern building line of Nos. 103 to 109 Valpy Avenue in a westerly direction to the road closure, including the eastern and western end of the road closure 'table'.

Vincent Road

South/West Side

Addition.

From its junction with Britannia Road to a point 10m east of the eastern back of the highway line of Britannia Road.

From a point in line with the boundary between 77 and 79 Vincent Road to a point 20m north of the southern boundary line of No.77 Vincent Road.

Vincent Road cont...
North Side

From its junction with Britannia Road to a point 10m east of the eastern back of the highway line of Britannia Road.

Watling Road

New provision

Both Sides

From a point in line with the boundary line between Nos. 6 and 8 Watling Road to a point in line with the boundary line between Nos.14 and 16 Watling Road.

Witard Close

New provision

Both Sides

From its junction with Witard Road to a point 10m east of the eastern back of the highway line of Witard Road.

Witard Road

New provision

West Side

From a point 10m north of the northern back of the highway line of Paine Road to a point 10m south of the southern back of the highway line of Paine Road.

East Side

From a point 10m north of the northern back of the highway line of Witard Close to a point 10m south of the southern back of the highway line of Witard Close.

Northern Area

North west side

From it's junction with Thorpe Road to it's junction with Harbour Road.

South east side

Addition

North Side

From it's junction with Carrow Road in an easterly direction to a point 17m west of the western back of the highway line of Heathside Road.

Wall Road

New provision.

North-eastern Side

From a point 3m north-west of the boundary line between Nos. 8 and 10 Wall Road to a point 3m south-east of the boundary line between Nos.16 and 18 Wall Road.

From a point 4m north of the boundary line between Nos. 84 and 86 Catton Grove Road to a point 59m south of Catton Grove Road junction with Mile Cross Lane.

From a point 63m south of its junction with Mile Cross Lane to a point 17m north of its junction with Brightwell Road

From a point 35m south-west of the south-western building line of No.49 Bessemer Road in a north-easterly direction for 12m.

From a point 5m north-east of the south-western building line of No.49 Bessemer Road to a point 9m south of the northern boundary line of the Bessemer Road Electricity Sub-Station.

South/East Side

From its junction with Sandy Lane to a point 2m south of the southern back of the highway line of Sandy Lane.

From its junction with Hall Road to a point 6m south-east of the eastern back of the highway line of Hall Road.

From a point 57m south-east of the eastern back of the highway line of Hall Road to a point 57m south-west of the south-western building line of No.49 Bessemer Road.

From a point 5m north-east of the south-western building line of No.49 Bessemer Road to a point 21m south of the northern building line of the Bessemer Road Electricity Sub-Station.

From a point 2m south of the southern boundary line of Gilchrist Close in a northerly direction for 16m.

From a point 29m north of the southern boundary line of Gilchrist Close in a northerly direction for 20m.

From a point 85m south of the southern back of the highway line of Sandy Lane in a southerly direction for 29m.

From its junction with Sandy Lane to a point 65m south of the southern back of the highway line of Sandy Lane.

Caroline Court

Both Sides

New provision.

From its junction with South Park Avenue to a point 30m west/north of the north-western back of the highway line of South Park Avenue.

Hall Road

West Side

Addition

From a point 8m north of the northern back of the highway line of Bessemer Road in a southerly direction for 35m.

Sandy Lane

South Side

Addition

From a point 10m west of the western back of the highway line of Bessemer Road in an easterly direction for 35m.

South Park Avenue

North Side

Addition

From a point 20m east of the eastern boundary line of Eaton Park in an easterly direction for 28m.

Wilberforce Road

Delete Previous and add

West Side

From its junction with Earlham Road to a point 44m north of the northern boundary line of No.603 Earlham Road.

East Side

From it's junction with Earlham Road to a point opposite the joint boundary line of No. 603 Earlham Road and No. 99 Friends Road.

South/East Side

From a point 6m east of the eastern back of the highway line of Hall Road to a point 57m east of the eastern back of the highway line of Hall Road.

From a point 57m south-west of the south western building line of No.49 Bessemer Road to a point 5m north-east of that building line.

From a point 21m south of the northern boundary line of the Bessemer Electricity Sub-Station in a northerly direction for 25m.

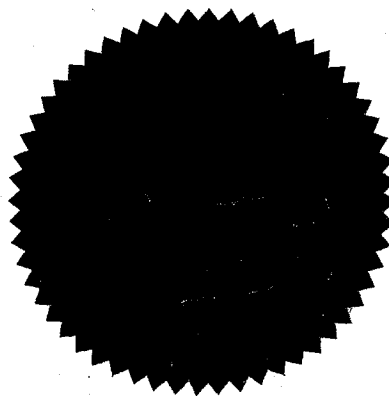
From a point 136m south of the southern back of the highway line of Sandy Lane in a southerly direction for 28m.
