NORWICH CITY COUNCIL

(HACKNEY CARRIAGE STANDS) TRAFFIC REGULATION ORDER 2002

The Norwich City Council pursuant to an Agency arrangement entered into with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1,2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby make the following Order:-

Citation and Commencement

This Order may be cited as the Norwich City Council (Hackney Carriage Stands) Traffic Regulation Order 2002 and shall come into effect for all purposes on the 16th September, 2002.

Definitions

"Hackney Carriage" has the same meaning as that defined in the Town Police Clauses Act 1847.

"Hackney Carriage Stand" means the areas of carriageway specified in the Schedules to this Order and indicated by traffic signs and markings 650.1 or 650.2 of the Traffic Signs Regulations and General Directions 1994.

- 3. Subject to Article 4 below no person shall cause or permit any vehicle other than a Hackney Carriage to wait in a Hackney Carriage Stand during the hours of operation of that Hackney Carriage Stand.
- 4. Article 3 above shall not prohibit the waiting of vehicles other than Hackney Carriages in the Hackney Carriage Stands specified in the Schedules to this Order during their hours of operation provided that the vehicle is a Police, Fire Brigade or Ambulance vehicle waiting in an emergency, or is a bus in a bus stop clearway.

SCHEDULE 1

HACKNEY CARRIAGE STAND HOURS OF OPERATION: At Any Time

St Peter Street West Side

From a point 45 metres north of the southern building line of City Hall to a point 73 metres north of that building line.

Queens Road North-East Side

From a point 40 metres north-west of its junction with the bus station entrance to a point 56 metres north-west of that junction.

Guildhall Hill South-Side

From a point 1.5 metres west of its junction with Gentlemans Walk to a point 21.5 metres west of that junction.

St Stephens Street South-East side

From a point 28 metres south-west of the south-western back of the highway line of Surrey Street to a point 45 metres south-west of that highway line.

Castle Meadow East Side

From a point 13 metres south of the northern boundary wall of Nos 5 and 6 Castle Meadow (adjacent to Arcade Street) to a point 33 metres south of that point.

Airport Access Road North East Side

In front of the terminal building from a point 21 metres south-east of the centre line of the central pedestrian access to the car park to a point 36 metres south-east of that centre line.

SCHEDULE 2

HACKNEY CARRIAGE STAND HOURS OF OPERATION: 7.00 p.m. to 7.00 a.m.

Magdalen Street

West Side

From a point 11 metres north of the northern back of the highway line of Colegate to a point 4 metres south of the common building line of Nos 8/10 and 12/14 Magdalen Street.

Prince of Wales Road

North Side

From a point 32 metres east of the back of the highway line of Upper King Street to the common building line of Nos 22 and 24/26 Prince of Wales Road.

SCHEDULE 3

HACKNEY CARRIAGE STAND HOURS OF OPERATION: 11.30 p.m. to 5.00 a.m.

Magdalen Street

West Side

From a point 8 metres north of the northern building line of No 58 Magdalen Street to a point 73 metres north of that building line.

Tombland West Side

From a point 8 metres north of the northern back of the highway line of Queen Street to a point 53 metres north of that highway line.

From the southern back of the highway line of Tombland Alley to a point 20 metres north of that highway line.

Tombland East Side

From a point 17 metres north of the northern (front) building line of Nos 27-29 Tombland to a point 43 metres north of that building line.

St Benedicts Street

South side

From a point 7 metres west of the western back highway line of St.Gregory's Back Alley to a point 22 metres west of that highway line.

SCHEDULE 4

HACKNEY CARRIAGE STAND HOURS OF OPERATION: 11.00 p.m. to 5.00 a.m.

Riverside West Side

From a point 6 metres north-west of the north-western side of the multi-storey car park northwards along the kerb line for a distance of 56 metres.

Riverside East Side

From a point 61 metres south of the southern boundary of Nos 2-6 Thorpe Road, southwards along the kerb line for a distance of 40 metres.

Bank Plain East Side

From a point 1 metre north of the centre line of the party wall between No.5 and No.7 Bank Plain to a point 6 metres north of the centre line of the party wall between No. 13 to 17 and No.19 Bank Plain.
