

**NORWICH CITY COUNCIL**  
**CITY CENTRE CONTROLLED PARKING ZONE**  
**(Amendment) TRAFFIC REGULATION ORDER 2004**

The City Council of Norwich pursuant to an agency arrangement entered in to under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 and all other enabling provisions of the Road Traffic Act 1984 hereby makes the following Order: -

1. **Citation and Commencement**

This Order may be cited as Norwich City Council City Centre Controlled Parking Zone (Amendment) Traffic Regulation Order 2004 which shall come into effect for all purposes on 1<sup>st</sup> November 2004.

2. The Norwich City Council City Centre Controlled Parking Zone (Consolidation) Traffic Regulation Order 2003 is amended as set out in Articles 3, 4, 5, 6 and 7 of this Order.
3. Schedules 1a and 1b amended by the inclusion of Lovelstaithe as specified in Schedules 1a and 1b of this Order.
4. Schedule 2 is amended by the introduction of waiting restrictions on Lovelstaithe as specified in Schedule 2 of this Order.
5. Schedule 4 is amended in respect of New Mills Yard as specified in Schedule 4 of this Order.
6. Schedule 15 is amended in respect of Exchange Street as specified in Schedule 15 of this Order.
7. Schedule 22 is amended in respect of Exchange Street as specified in Schedule 22 of this Order.

- (i) the north side from a point 27 metres west of the western building line of Oak Street Medical Practice to a point 48 metres west of that building line

**And replace with the following new provision**

- (i) the north side from a point 66.5 metres west of the western back of highway line of Oak Street to a point 78.5 metres west of the western back of highway line of Oak Street.

**Schedule No 15      No Loading or Unloading At Any Time**

**Exchange Street**

**Delete existing provision**

- (i) the west side from the common boundary line of Nos. 14 and 16 Exchange Street to the junction with Lobster Lane

**And replace with the following additional provision**

- (i) the west side from the common boundary line of Nos. 14 and 16 Exchange Street to the junction with Charing Cross



**Delete existing provision**

- (i) the west side from the common building line of Nos. 4b and 4c Exchange Street to the junction with Charing Cross
