NORWICH CITY COUNCIL

(RAMPANT HORSE STREET, RED LION STREET AND SURREY STREET) (WAITING RESTRICTIONS) TRAFFIC REGULATION ORDER 2005

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2, 4 and 45 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. Citation and Commencement

This Order may be cited as the "Norwich City Council (Rampant Horse Street, Red Lion Street and Surrey Street) (Waiting Restrictions) Traffic Regulation Order 2005" and shall come into effect for all purposes on the 14th day of January 2005.

- 2. The Norwich City Council (City Centre Controlled Parking Zone) (Consolidation) Traffic Regulation Order 2003 (as amended) is amended as specified in Articles 3 to 9 inclusive of this Order.
- 3. The following paragraph is added as Article 3 (8b)
 - "Nothing in Article 3 (8) shall apply to a vehicle that is loading or unloading on Rampant Horse Street to the premises at numbers 12 to 14 Brigg Street."
- 4. The following paragraph is added as Article 3 (8c)
 - "Nothing in Article 3 (8) shall apply to a vehicle that is loading or unloading to the premises at numbers 1 and 3 Red Lion Street and that is parked directly outside those premises."
- 5. References to Rampant Horse Street, Red Lion Street, Theatre Street and Surrey Street in Schedule 15 are amended as specified in Schedule 15 of this Order.
- 6. Reference to Red Lion Street in Schedule 16 is amended as specified in Schedule 16 of this Order.
- 7. References to Rampant Horse Street and Red Lion Street in Schedule 22 are amended as specified in Schedule 22 of this Order.
- 8. References to Orford Place in Schedule 27 are amended and reference to Red Lion Street in Schedule 27 is added as specified Schedule 27 of this Order.
- 9. Reference to Surrey Street in Schedule 30 is deleted as detailed in Schedule 30 of this Order.
