

NORWICH CITY COUNCIL (ROSE LANE)
(WAITING RESTRICTIONS) TRAFFIC REGULATION ORDER 2004

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. **Citation and Commencement**

This Order may be cited as the "Norwich City Council (Rose Lane) (Waiting Restrictions) Traffic Regulation Order 2004" and shall come into effect for all purposes on the 8th day of December 2004.

2. The Norwich City Council (City Centre Controlled Parking Zone) (Consolidation) Traffic Regulation Order 2003 (as amended) is amended as specified in Articles 3, 4, 5 and 6 of this Order.

3. The following paragraph is added as Article 3 (8a) –

"Nothing in Article 3 (8) shall apply to a vehicle that is loading or unloading at the warehouse at numbers 64 to 70 Rose Lane, on behalf of Gerald Giles and subject to the following conditions:-

- (i) the vehicle is no larger than 13 metres in length;
- (ii) there shall be loading or unloading between the hours of 07:30 to 09:30 and 16:30 to 18:30;
- (iii) the vehicle must wait in the area of carriageway on Rose Lane directly outside numbers 64 – 70 Rose Lane".

4. References to Rose Lane in Schedule 15 are amended as specified in Schedule 15 of this Order.

5. References to Rose Lane in Schedule 16 are deleted as specified in Schedule 16 of this Order.

6. References to Rose Lane in Schedule 22 are amended as specified in Schedule 22 of this Order.

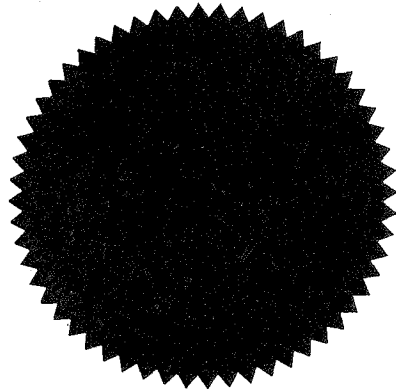
