# Norwich City Council (South-Western Controlled Parking Zone) (Ipswich Road) Amendment Traffic Regulation Order 2005

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

#### 1. <u>Citation and Commencement</u>

This Order may be cited as the "Norwich City Council (South-Western Controlled Parking Zone) (Ipswich Road) Amendment Traffic Regulation Order 2005" and shall come into effect for all purposes on the 16<sup>th</sup> day of September 2005.

2. The Norwich City Council (Controlled Parking Zones) (South Western Area) Traffic Regulation Order 1996 (as amended) is amended in respect of references to Ipswich Road in Schedules 2, 6 and 16 as specified in Schedules 2, 6 and 16 of this Order.
