

**NORWICH CITY COUNCIL SOUTH WESTERN CONTROLLED  
PARKING ZONE ( FELLOWES PLAIN AMENDMENT)**

**TRAFFIC REGULATION ORDER 2004**

The Norwich City Council, pursuant to an agency arrangement entered into under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2, 4, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 and all other enabling powers, and after consultation with the Chief Officer of Police hereby makes the following order.

1. This Order is made on the 25<sup>th</sup> day of March 2004 and shall come into effect for all purposes on the 1<sup>st</sup> April 2004. The Order may be cited as the Norwich City Council South Western Controlled Parking Zone (Fellowes Plain Amendment) Traffic Regulation Order 2004.
2. The Schedules of the Norwich City Council South Western Controlled Parking Zone Traffic Regulation Order 1996 (hereinafter the "1996 Order") as amended are further amended as set out in articles 3 to 8 below.
3. Schedule 1 is amended by the deletion of previous references to Brunswick Road, Newmarket Road and Union Street and the insertion of new references to Brunswick Road Nos 1-41 odds, Newmarket Road, Nos 5-7 odds, Launceston Terrace 1-11 and Union Street (Melbourne Cottages) as set out in Schedule 1 of this Order.
4. Schedule 2 is amended by the deletion of references to Brunswick Road and the insertion of new references to Brunswick Road, Thomas Wyatt Close, Sarah West Close and Edward Jodrell Plain as set out in Schedule 2 of this Order.
5. Schedule 4 is amended by the deletion of a reference to Brunswick Road and the insertion of new references to Brunswick Road and Edward Jodrell Plain as set out in Schedule 4 of this Order.
6. Schedule 5 is amended by the addition of new references to Brunswick Road as set out in Schedule 5 of this Order.
7. Schedule 6 is amended by the deletion of references to Brunswick Road as set out in Schedule 6 of this Order.
8. Schedule 15 is amended by the deletion of references to Brunswick Road as set out in Schedule 15 of this Order.
9. The headings of Sections 2, 3, 4 and 5 of the 1996 Order are amended by the deletion of the words "referred to in Schedule 3".

10. Article 18 (1) of the 1996 Order is amended by the addition of the following sentence -

No Residents Parking Permits shall be issued to those persons residing at properties specified in the column "properties for the purposes of issuing parking permits" in Schedule 1a.

11. Article 19 (1) is amended to add at the end of the article the following: "except that Residents Parking Permits are not valid for parking in the Permit Holder's Parking Places marked FP in Schedule 4"

12. Article 19 (2) of the 1996 Order is amended to add at the end of the article the following: "Residents Parking Permits may not be used for parking in the designated permit parking places marked FP in Schedule 4."

13. Article 22 (1) of the 1996 Order is amended to read as follows -

A residents visitors parking permit shall only be used for the purpose of allowing a resident's visitor to leave a vehicle in a permit holders parking place whilst visiting a resident within the controlled sub zone to which the permit relates except that residents visitors parking permits marked FP may only be used within the designated permit parking places marked FP in Schedule 4 and residents visitors parking permits not marked FP may not be used within the designated permit parking places marked FP in Schedule 4.

14. Article 22 (2) of the 1996 Order is amended to read as follows -

Each residents visitors parking permit shall only be valid for use in the sub zone specified in the permit except that residents visitors parking permits marked FP are only valid for use in those designated parking places marked FP in Schedule 4 and residents visitors parking permits not marked FP may not be used within the designated permit parking places marked FP in Schedule 4.

15. Article 24 (2) of the 1996 Order is amended by the addition of the following sentence -

No business users parking permits shall be issued to those properties specified in the column "properties for the purposes of issuing parking permits" in Schedule 1a.

16. The 1996 Order is amended by the addition of Schedule 1a of this Order inserted as a Schedule numbered 1a, between Schedule 1 and Schedule 2.

17. Articles 6 and 7 of the 1996 Order are amended by the addition of the words "subject to the following provisions of this Order," at the beginning of both articles.

## Schedule 2

### No Waiting At Any Time

#### Delete the following references

- (1) Brunswick Road, the east side, from its junction with Newmarket Road to a point 32 metres north of the northern back highway line of Newmarket Street
- (2) Brunswick Road, the east side, from a point 85 metres north of the northern back highway line of Newmarket Road to a point opposite the boundary line of Nos.23 and 25 Brunswick Road
- (3) Brunswick Road, the east side, from a point opposite the boundary between Nos. 39 and 41 Brunswick Road to its junction with Union Street
- (4) Brunswick Road, the west side, from its junction with Newmarket Road to the boundary line of Nos. 5 and 7 Brunswick Road
- (5) Brunswick Road, the west side, the boundary line between Nos. 15 and 17 Brunswick Road to its junction with Cambridge Street

#### Insert new provisions

- (1) Brunswick Road, both sides from a point 4 metres northwest of the boundary of Nos. 23/25 Brunswick Rd to a point 1 metres northwest of the boundary of Nos. 15/17 Brunswick Rd
- (2) Brunswick Road, both sides from its junction with Cambridge Street to a point 3 metres south-east of the boundary of Nos. 39/41 Brunswick Rd
- (3) Brunswick Road, the northeast side from its junction with Newmarket Road to a point 10 metres south-east of the south-eastern back of highway line of Hanover Road
- (4) Brunswick Road, the south-west side from a point 4 metres south-east of the boundary of Nos. 33/35 Brunswick Rd to a point 5 metres northwest of the boundary of Nos. 27/31 Brunswick Rd
- (5) Brunswick Road, the southwest side from a point 6 metres southeast of the boundary of Nos. 5/7 Brunswick Rd for a distance of 15 metres in a south-easterly direction
- (6) Brunswick Road, the southwest side from a point 16 metres southeast of the south-eastern

back of highway line of Hanover Road for a distance of 19 metres in an south-easterly direction

- (7) Brunswick Road, the southwest side from its junction with Newmarket Road to a point 36 metres north-west of the north-western back of highway line of Newmarket Road
- (8) Thomas Wyatt Close, both sides for its entire length.
- (9) Sarah West Close, both sides for its entire length
- (10) Edward Jodrell Plain, both sides except for the spaces marked on the west side from a point perpendicular to the northern property boundary of No. 19 Edward Jodrell Plain for a distance of 20 metres in a southerly direction, extending to a depth of 5 metres

**Delete the following references**

- (1) Brunswick Road, the west side, from the boundary line between No 5 and 7 Brunswick Road to the boundary line between No 15 and 17 Brunswick Road

<b>S</b>	Brunswick Road, the southwest side from a point 5 metres northwest of the boundary of Nos. 27/31 Brunswick Rd to a point 4 metres northwest of the boundary of Nos. 23/25 Brunswick Rd
<b>S</b>	Brunswick Road, the southwest side from a point 2.5 metres southeast of the south-eastern back of highway line of Hanover Road for a distance of 13.5 metres in an south-easterly direction
<b>S</b>	Brunswick Road, the southwest side from a point 1 metres northwest of the boundary of Nos. 15/17 Brunswick Rd to a point 6 metres southeast of the boundary of Nos. 5/7 Brunswick Rd
<b>FP</b>	Brunswick Road, the north-east side from a point opposite 3 metres south-east of the boundary of Nos. 39/41 Brunswick Rd to a point opposite 4 metres north-west of the boundary of Nos. 23/25 Brunswick Rd
<b>FP</b>	Edward Jodrell Plain, the west side from a point perpendicular to the northern property boundary of No. 19 Edward Jodrell Plain for a distance of 20 metres in a southerly direction extending to a depth of 5 metres

#### **Insert new provisions**

- (1) Brunswick Road, the north-east side from a point opposite 1 metre north-west of the boundary of Nos. 15/17 Brunswick Rd to a point 10 metres southeast of the southeastern back of highway line of Hanover Road
  
- (2) Brunswick Road, the south-west side from a point 36 metres north-west of the Northwestern back of highway line of Newmarket Road to a point 35 metres southeast of the southeastern back of highway line of Hanover Road
  
- (3) Brunswick Road, the southwest side from a point 3 metres southeast of the boundary of Nos. 39/41 Brunswick Rd to a point 4 metres southeast of the boundary of Nos. 33/35 Brunswick Rd

### **Schedule 6**

**Limited Waiting Parking Place, 2 Hours Duration,  
No Return Within 1 Hour Mon-Sat 8am-6.30pm Any Such Day Not Being Christmas Day,  
Good Friday or a Bank Holiday**

#### **Delete the following references**

- (1) Brunswick Road, the east side, from a point 32 metres north of the northern back of highway line of Newmarket Road to a point 15.5 metres north of the northern back of highway line of Newmarket Street
  
- (2) Brunswick Road, the east side, from a point opposite the boundary line between Nos. 23 & 25 Brunswick Road to a point opposite the boundary line of Nos. 39 & 41 Brunswick Road

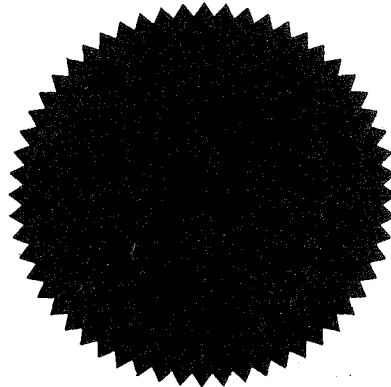

**Delete the following references**

- (1) Brunswick Road, the east side, from its junction with Newmarket Road to a point 32 metres north of the northern back highway line of Newmarket Street
- (2) Brunswick Road, the east side, from a point 85 metres north of the northern back highway line of Newmarket Road to a point opposite the boundary line of Nos.23 and 25 Brunswick Road
- (3) Brunswick Road, the east side, from a point opposite the boundary between Nos. 39 and 41 Brunswick Road to its junction with Union Street
- (4) Brunswick Road, the west side, from its junction with Newmarket Road to the boundary line of Nos. 5 and 7 Brunswick Road
- (5) Brunswick Road, the west side, the boundary line between Nos. 15 and 17 Brunswick Road to its junction with Cambridge Street
