NORWICH CITY COUNCIL

(CONTROLLED PARKING ZONES) (SOUTH EAST AREA) (SIGISMUND ROAD) TRAFFIC REGULATION ORDER 2005

The City Council of Norwich pursuant to an agency arrangement entered in to under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 and all other enabling provisions of the Road Traffic Act 1984 hereby make the following Order: -

1. Citation and Commencement

This Order may be cited as The Norwich City Council (Controlled Parking Zones) (South East Area) (Sigismund Road) Traffic Regulation Order 2005 which shall come into effect for all purposes on the 23rd day of May 2005.

- 2. The Norwich City Council (Controlled Parking Zones) (South East Area) Traffic Regulation Order 1993 is amended as set out in Articles 3, 4, 5 and 6 of this Order.
- 3. Schedule 2 is amended by the introduction of 'no waiting at any time' restrictions on Sigismund Road as specified in Schedule 2 of this Order.
- 4. Schedule 3 is amended in respect of Sigismund Road as specified in Schedule 3 of this Order.
- 5. The following paragraph is added as Article 3 (6): -
 - "No person shall cause or permit any vehicle to wait in the lengths of road mentioned in Schedule 64 between the hours of 8.00am to 6.30pm Monday to Friday, and any such day not being Christmas Day, Good Friday or a Bank Holiday."
- 6. A Schedule 64 is added containing the details specified in Schedule 64 to this Order.

Sigismund Road - New Provision

(i) the south side from a point opposite the eastern building line of Nos. 4 and 8 Dawson Court Sigismund Road in an easterly direction around the cul-de-sac end to a point 5 metres north of the southern back of highway line of Sigismund Road

Schedule 3 Permit Parking Places: 8am to 6.30pm Monday to Saturday

Delete the following provision :-

Sigismund Road

- (i) the north side from the building line of Nos. 3 and 5 Sigismund Road to its easterly extremity
- (ii) the south side from the building line of Nos. 7 and 9 Sigismund Road in an easterly direction to its eastern extremity

And replace with the following provision :-

Sigismund Road

- (i) the north side from the building line of Nos. 3 and 5 Sigismund Road in an easterly direction to the eastern building line of Nos. 4 and 8 Dawson Court Sigismund Road
- (ii) the south side from the building line of Nos. 7 and 9 Sigismund Road in an easterly direction to a point opposite the eastern building line of Nos. 4 and 8 Dawson Court Sigismund Road

Schedule 64 No Waiting 8am to 6.30pm Monday to Friday

Sigismund Road

(i) the north side from the eastern building line of Nos. 4 and 8 Dawson Court Sigismund Road around the cul-de-sac end to a point 5 metres north of the southern back of highway line of Sigismund Road
