# NORWICH CITY COUNCIL (CONTROLLED PARKING ZONES) (SOUTH EAST AREA) (HALL ROAD) TRAFFIC REGULATION ORDER 2004

The City Council of Norwich pursuant to an agency arrangement entered in to under Section 101 of the Local Government Act 1972 with the Norfolk County Council, and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 and all other enabling provisions of the Road Traffic Act 1984 hereby makes the following Order: -

### 1. Citation and Commencement

This Order may be cited as The Norwich City Council (Controlled Parking Zones) (South East Area) (Hall Road) Traffic Regulation Order 2004 which shall come into effect for all purposes on the 1<sup>st</sup> day of November 2004.

- 2. The Norwich City Council (Controlled Parking Zones) (South East Area) Traffic Regulation Order 1993 is amended as set out in Articles 3 and 4 of this Order.
- 3. References to Hall Road in Schedule 2 are amended as specified in Schedule 2 of this Order.
- 4. References to Hall Road in Schedule 7 are amended as specified in Schedule 7 of this Order.

#### Delete existing provision

(i) the west side from a point 9.5 metres north of the centre line of Harford Street in a southerly direction to a point 6 metres south of that centre line.

#### And replace with the following new provision

(i) the west side from a point 10 metres north of the northern back of highway line of Harford Street to a point 2 metres south of the southern back of highway line of Harford Street.
