AMENDMENT TRAFFIC REGULATION ORDER 2005

The City Council of Norwich pursuant to an arrangement made under Section 101 of the local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4, of the Road Traffic Regulation Act and all other enabling powers hereby makes the following Order: -

Citation and Commencement

1. This Order may be cited as the Norwich City Council (Central Pedestrianised Areas) (Chantry Road, Malthouse Road, City Walls Walk and Coburg Street) Amendment Traffic Regulation Order 2005 and shall come into effect for all purposes on the 5th of September 2005.
2. The Norwich City Council (Central Pedestrianised Areas) Traffic Regulation Order 2000 (as amended) is amended as specified in Articles 3, 4 and 5 below to this Order.
3. The following paragraph is added as Article 3(a) (i) :-

“Nothing in Article 3 (a) shall apply to a vehicle delivering to the servicing bays on Malthouse Road associated with property numbers 21 to 25 Rampant Horse Street and numbers 2 to 8 St Stephens Street (currently occupied by Marks and Spencer) and 12 St Stephens Street (currently occupied by Superdrug) between the hours of 5.00pm and midnight and 0.01am and 10.00am and at any time to St Stephens Church”.
4. The following paragraph is added as Article 3(a) (ii) :-

“Nothing in Article 3 (a) shall apply to a vehicle delivering to the servicing bays on Malthouse Road associated with property number 70 St Stephens Street (currently occupied by Norwich and Ipswich Co-Operative Society) at any time.”
5. Schedule 1 is amended by the addition of reference to Malthouse Road as specified in Schedule 1 of this Order.
6. Schedule 5 is amended by the addition of references to Chantry Road, City Walls Walk, Coburg Street and Malthouse Road as specified in Schedule 5 of this Order.

Malthouse Road

Insert the following new provisions

Chantry Road

For its entire length.

City Walls Walk

For its entire length.

Coburg Street

For its entire length.

Malthouse Road

From its junction with Coburg Street to a point 32 metres north-east of the southern back of highway line of Coburg Street.

From a point 68 metres south-west of the southern back of highway line of Rampant Horse Street in a south-westerly direction to include the cul de sac at the southern spur of Malthouse Road.
