# NORWICH CITY COUNCIL (NORTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING) (NORTHFIELDS) AMENDMENT TRAFFIC REGULATION ORDER 2011

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of Norfolk County Council under Sections 1, 2 and 4, of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

## 1. Citation and Commencement

This Order may be cited as the "Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting) (Northfields) Amendment Traffic Regulation Order 2011" and shall come into effect for all purposes on the 24<sup>th</sup> day of October 2011.

- 2. The Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 (hereinafter called "the 1982 Order") is amended as specified in Articles 3 and 4 of this Order.
- 3. Schedule 2 of the 1982 Order is amended by the addition of references to Northfields as specified in Schedule 1 of this Order.
- 4. Schedule 16 of the 1982 Order is amended by the addition of references to Northfields as specified in Schedule 2 of this Order.
