CITY CENTRE CONTROLLED PARKING ZONE

AMENDMENT TRAFFIC REGULATION ORDER 2012

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (City Centre Controlled Parking Zone) Amendment Traffic Regulation Order 2012 and shall come into effect for all purposes on the 16th day of January 2012.

- 2. The Norwich City Council City Centre Controlled Parking Zone (Consolidation) Traffic Regulation Order 2003 (as amended) (hereinafter referred to as the "2003 Order") is amended as specified in Articles 3, 4, 5, 6, and 7 of this Order.
- In Schedule 4 of the 2003 Order references to Music House Lane is amended and references to St Martins Lane is added as specified in Schedule 1 of this Order.
- 4. In Schedule 28 of the 2003 Order reference to St Giles Street is amended as specified in Schedule 2 of this Order.
