

NORWICH CITY COUNCIL
(CROME ROAD AND SOUTHALLS WAY) (PEDESTRIANISED AREA)
TRAFFIC REGULATION ORDER 2009

The City Council of Norwich (hereinafter referred to as 'the Council') pursuant to arrangements made under Section 101 of the Local Government Act, 1972 with Norfolk County Council, in exercise of the powers of the said County Council under Sections 1, 2, 4 and 122A of the Road Traffic Regulation Act, 1984 and all other enabling provisions hereby makes the following Order:-

1. Citation and commencement

This Order may be cited as the Norwich City Council (Crome Road and Southalls Way) (Pedestrianised Area) Traffic Regulation Order 2009 and shall come into effect for all purposes on the 30th day of September 2009.

Definitions

2. Save as provided for in Articles 3 and 4 of this Order, no person shall, except on the direction of a uniformed Officer of the Council or Norfolk Constabulary, drive or propel, or cause to permit to be driven or propelled any vehicle at any time on Crome Road from a point 30 metres north of the back of highway line of Romany Road to its junction with Southalls Way or on the entire length of Southalls Way.
3. Nothing in Article 2 shall prevent any person from causing or permitting any vehicle to be driven in the defined section of Crome Road or in Southalls Way if -
- (i) it is a motorised disabled persons cart
 - (ii) it is being used in connection with a funeral
 - (iii) it is being used in connection with any building operation or demolition, the removal of obstruction to traffic, the maintenance, improvement, or reconstruction of any lengths of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or telecommunications provided that the vehicle cannot be conveniently stored for such purpose in any other road
 - (iv) it is being used by a medical practitioner or for fire brigade, ambulance, police or civil defence purposes
 - (v) it is being used to access or egress private parking areas
 - (vi) it is a pedal cycle
 - (vii) it is a handcart
 - (viii) It is a vehicle controlled by a pedestrian.

4. Nothing in Article 2 shall prevent any person from causing or permitting any vehicle to be driven, or to wait in the defined section of Crome Road or in Southalls Way for the following purposes :
- (i) to enable goods or merchandise to and from premises adjoining, or with access from Crome Road or Southalls Way to be loaded on to or unloaded from the vehicle;
 - (ii) for the purposes of collecting or delivering postal packets;
 - (iii) for the collection of refuse;
 - (vi) to gain access to or egress from the designated on-street parking places and park the vehicle therein
