

**NORWICH CITY COUNCIL**  
**(EASTERN CONTROLLED PARKING ZONE) (KETTS HILL)**  
**AMENDMENT TRAFFIC REGULATION ORDER 2011**

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. Citation and Commencement

This Order may be cited as the Norwich City Council (Eastern Controlled Parking Zone) (Ketts Hill) Amendment Traffic Regulation Order 2011 and shall come into effect for all purposes on the 21<sup>st</sup> day of March 2011.

2. The Norwich City Council Eastern Controlled Parking Zone Traffic Regulation Order 1999 (as amended) is amended as specified in Articles 3 and 4 below.
3. References to Ketts Hill in Schedule 2 are amended as specified in Schedule 1 of this Order.
4. References to Ketts Hill in Schedule 3 are amended as specified in Schedule 2 of this Order.
5. Insofar as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in Articles 3 and 4 and the Schedules to this Order, that provision of this Order shall prevail.
