# THE CITY COUNCIL OF NORWICH (NORTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING) (DIBDEN ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2011

The City Council of Norwich City Council in exercise of the powers of Norfolk County Council under Sections 1(1), 2(1), 2(2) and 4(1) and 4(2) and 122 and and parts III and IV of Schedule 9 of the Road Traffic Regulation Act, 1984 (hereinafter referred to as "the Act") and of all other enabling powers pursuant to an arrangement made with Norfolk County Council under Section 101 of the Local Government Act 1972 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

### 1. <u>Citation and Commencement</u>

This Order may be cited as "The City Council of Norwich (Prohibition and Restriction of Waiting)(Dibden Road) Amendment Traffic Regulation Order 2011 and shall come into effect for all purposes on the 15<sup>th</sup> day of April 2011.

- 2. The Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting (Consolidation) Order 1982 (as amended) is amended as specified in Articles 3 to 5 of this Order.
- 3. In Schedule 1 references to Dibden Road are amended as specified in Schedule 1 of this Order.
- 4. In Schedule 3 references to Dibden Road are amended as specified in Schedule 2 of this Order.
- 5. In Schedule 9 references to Dibden Road are amended as specified in Schedule 3 of this Order.
- 6. Insofar as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in Articles 3, 4 and 5 and the Schedules to this Order, that provision of this Order shall prevail.
