

**NORWICH CITY COUNCIL**  
**(SOUTH-WESTERN CONTROLLED PARKING ZONE)**  
**(ALBEMARLE ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2009**

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. **Citation and Commencement**

This Order may be cited as the "Norwich City Council (South-Western Controlled Parking Zone) (Albemarle Road) Amendment Traffic Regulation Order 2009" and shall come into effect for all purposes on the 6<sup>th</sup> day of April 2009.

2. The Norwich City Council (Controlled Parking Zones) (South Western Area) Traffic Regulation Order 1996 (as amended) is amended by the amendment of the references to Albemarle Road in Schedules 2 and 6 as specified in Schedules 2 and 6 of this Order.
