NORWICH CITY COUNCIL ((EASTERN CONTROLLED PARKING ZONE) (LOWER CLARENCE ROAD BUS LAYOVER) AMENDMENT TRAFFIC REGULATION ORDER 2013

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under sections 1, 2, 4, 45 and 46 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. Citation and Commencement

This Order may be cited as the Norwich City Council (Eastern Controlled Parking Zone) (Lower Clarence Road Bus Layover) Amendment Traffic Regulation Order 2013 and shall come into effect for all purposes on the 17th day of June 2013.

- 2. The Norwich City Council Eastern Controlled Parking Zone Traffic Regulation Order 1999 (as amended) (hereinafter referred to as the "1999 Order") is amended as specified in Articles 2 to 9 of this Order.
- 3. The following definition is added in Article 2:

"Local Bus" has the same meaning as stated in Section 1 of The Traffic Signs Regulations and General Directions 2002 and any subsequent revisions.

4. The following Article is added as Article 12(9):

"A person may cause or permit a local bus to wait in any lengths of road specified in Schedule 210 and marked in accordance with sign ref 661.1 variant at any time for a maximum period of 2 hours, no return within 4 hours."

- 5. A Schedule 210 is added, containing the details specified in Article 4 and Schedule 3 of this Order.
- 6. Reference to Lower Clarence Road in Schedule 6 is amended as specified in Schedule 1 of this Order.
- 7. Reference to Lower Clarence Road in Schedule 20 is amended as specified in Schedule 2 of this Order.
- 8. Reference to Lower Clarence Road in Schedule 120 is added as specified in Schedule 3 of this Order.
