# NORWICH CITY COUNCIL (NORTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING) (DRAYTON ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2014

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

# 1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting) (Drayton Road) Amendment Traffic Regulation Order 2014 and shall come into effect for all purposes on the 20th day of February 2014.

- 2. The Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 (as amended) (hereinafter referred to as the "1982 Order") is amended as specified in Articles 3 to 7 of this Order.
- 3. The following article is added as Article 24:-
  - "24. No person shall cause or permit any vehicle to wait in the lengths of road mentioned in Schedule 64 between 8 a.m. and 6:30 p.m., Monday to Friday, any such day not being Christmas Day, Good Friday or a Bank Holiday."
- 4. Schedule 64 is added, containing the details specified in Article 3 and Schedule 3 of this Order.
- 5. In Schedule 1 of the 1982 Order reference to Drayton Road is amended as specified in Schedule 1 of this Order.
- 6. In Schedule 55 of the 1982 Order reference to Drayton Road is amended as specified in Schedule 2 of this Order.
- 7. In Schedule 64 of the 1982 Order reference to Drayton Road is added as specified in Schedule 3 of this Order.
