NORWICH CITY COUNCIL (CONTROLLED PARKING ZONES) DUKE STREET, GAOL HILL, MAGDALEN CLOSE, MAGDALEN STREET, SAUNDERS COURT, WESSEX STREET) AMENDMENT TRAFFIC REGULATION ORDER 2015

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2, 4 and 45 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (Controlled Parking Zones) (Duke Street, Gaol Hill, Magdalen Close, Magdalen Street, Saunders Court, Wessex Street) Amendment Traffic Regulation Order 2015 and shall come into effect for all purposes on the 6th day of April 2015.
