

**NORWICH CITY COUNCIL
(NORTHERN AREA AND RIVERSIDE)
(PROHIBITION AND RESTRICTION OF WAITING)
(MISCELLANEOUS) AMENDMENT TRAFFIC REGULATION ORDER 2015**

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. Citation and Commencement

This Order may be cited as the Norwich City Council (Northern Area and Riverside) (Prohibition and Restriction of Waiting) (Miscellaneous) Amendment Traffic Regulation Order 2015 and shall come into effect for all purposes on the 6th day of April 2015.

2. The Norwich City Council (Northern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 (as amended) (hereinafter called the "1982 Order") is amended as specified in Articles 5 and 6 of this Order.
3. The City of Norwich (Riverside Area Prohibition and Restriction of Waiting) Traffic Regulation Order 1999 (as amended) (hereinafter called the "1999 Order") is amended as specified in Article 7, 8 and 9 of this Order.
4. The Norwich City Council (Hackney Carriage Stands) Traffic Regulation Order 2002 (as amended) (hereinafter called the "2002 Order") is amended as specified in Articles 10 and 11 of this Order.
5. In Schedule 1 of the 1982 Order the reference to Thorpe Road is amended as specified in Schedule 1 of this Order.
6. In Schedule 55 of the 1982 Order the reference to Thorpe Road is deleted as specified in Schedule 2 of this Order.
7. The following paragraph is added as Article 3 (12) to the 1999 Order:-

"3.(12) A person may cause or permit a vehicle to wait in the streets or parts of streets mentioned in Schedule 66 of this Order during the period 4:00 am. to 9:00pm for the purpose of loading or unloading only. At all other times no person shall cause or permit any vehicle other than a hackney carriage to wait for any period in the streets or parts of streets mentioned in Schedule 66 of this Order."
8. In Schedule 66 of the 1999 Order the reference to Riverside Road is added as specified to Schedule 3 of this Order.

9. In Schedule 96 of the 1999 Order the reference to Riverside Road is deleted as specified in Schedule 4 of this Order.
10. The following paragraph is added as Article 3 (11) to the 2002 Order:-

"3.(12) A person may cause or permit a vehicle to wait in the streets or parts of streets mentioned in Schedule 66 of this Order during the period 4:00 am. to 9:00pm for the purpose of loading or unloading only. At all other times no person shall cause or permit any vehicle other than a hackney carriage to wait for any period in the streets or parts of streets mentioned in Schedule 66 of this Order."
11. In Schedule 66 of the 2002 Order the reference to Riverside Road is added as specified to Schedule 3 of this Order.
12. Insofar as any provision of any previous Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.

(Northern area)	<u>North side</u>
Zone D	From the boundary of Nos. 198/200 Thorpe Road to a point 10 metres east of the eastern back of highway line of Telegraph Lane East

Delete the following reference:-

Zone D	<u>North side</u>
