

**NORWICH CITY COUNCIL
(CITY CENTRE CONTROLLED PARKING ZONE)
(MAGDALEN STREET AND COWGATE)
AMENDMENT TRAFFIC REGULATION ORDER 2015**

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under sections 1, 2, 4, 45, 46 and 122A of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. Citation and Commencement

This Order may be cited as the Norwich City Council (City Centre Controlled Parking Zone) (Magdalen Street and Cowgate) Amendment Traffic Regulation Order 2015 and shall come into effect for all purposes on the 20th day of April 2015.

2. The Norwich City Council City Centre Controlled Parking Zone (Consolidation) Traffic Regulation Order 2003 (as amended) (hereinafter referred to as the "2003 Order") is amended as specified in Articles 3 and 4 of this Order.
3. References to Magdalen Street in Schedule 22 of the 2003 Order are deleted as specified in Schedule 1 of this Order.
4. References to Magdalen Street in Schedule 46 of the 2003 Order are amended as specified in Schedule 2 of this Order.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.


