Norwich City Council pursuant to its powers under an agency agreement with the Norfolk County Council and in exercise of its powers, under Section 3 of the Cycle Tracks Act 1984 hereby makes the following Order: -

- 1. This Order may be cited as the "Barrett Road, Hall Road, Sandy Lane, Bessemer Road, Saint Johns Close Cycle Track Order 2015".
- 2. The lengths of footpath set out in (i), (ii), (iii), (iv), (v), (vi), (vii) and (viii) below are declared to be unsegregated cyclepath/footpath for use by persons travelling on foot or by pedal cycle:-
 - (i) the eastern footway of C820 Hall Road from the roundabout junction with A146 Barrett Road to a point 553m south-west of the junction;
 - (ii) the southern footway of U41653 Sandy Lane from the junction with C820 Hall Road to a point 30m south-east of the centre of its junction with U41607 Bessemer Road; a total length of 197m;
 - (iii) the western footway of U41607 Bessemer Road from the junction with U41653 Sandy Lane to a point 30m south-west of the junction;
 - (iv) the western footway of C820 Hall Road from a point 16m north east of the centre of the U42852 Saint Johns Close junction to a point 31m south of the roundabout junction with A146 Barrett Road; a total length of 570m;
 - (v) the southern footway of A146 Barrett Road from the roundabout junction with C820 Hall Road to a point 111m east of its junction;
 - (vi) the northern footway of A146 Barrett Road from a point 97m east of the roundabout junction with C820 Hall Road for a length of 12m;
