NORWICH CITY COUNCIL (SOUTH-EASTERN CONTROLLED PARKING ZONE) (BRAZEN GATE PERMIT PARKING SCHEME) AMENDMENT TRAFFIC REGULATION ORDER 2015

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under sections 1, 2, 4, 45 46 and 122A of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (South-Eastern Controlled Parking Zone) (Brazen Gate Permit Parking Scheme) Amendment Traffic Regulation Order 2015 and shall come into effect for all purposes on the 1st day of September 2015.

- 2. The Norwich City Council (Controlled Parking Zone) (South-East Area) Traffic Regulation Order 1993 (as amended) (hereinafter called the 1993 Order") is amended as specified in Articles 3 to 8 of this Order.
- 3. The definition of 'operational date' is amended by the addition of references to properties at 2-172 (evens) Brazen Gate for which the operational date is 30th June 2016.
- 4. References to Brazen Gate in Schedule 1 of the 1993 Order are amended as specified in Schedule 1 of this Order.
- 5. References to Brazen Gate are added to Schedule 1A as specified in Schedule 1A of this Order
- 6. References to Brazen Gate in Schedule 2 of the 1993 Order are amended as specified in Schedule 2 of this Order.
- 7. References to Brazen Gate in Schedule 4 of the 1993 Order are added as specified in Schedule 3 of this Order.
- 8. References to Brazen Gate in Schedule 14 of the 1993 Order are amended as specified in Schedule 3 of this Order.
