

**NORWICH CITY COUNCIL  
(SOUTHERN AREA)  
(PROHIBITION AND RESTRICTION OF WAITING)  
(HALL ROAD DISTRICT CENTRE)  
AMENDMENT TRAFFIC REGULATION ORDER 2015**

The City Council of Norwich (hereinafter referred to as 'the Council') pursuant to arrangements made under Section 101 of the Local Government Act, 1972 with Norfolk County Council, in exercise of the powers of the said County Council under Sections 1, 2 and 4 and 122A and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act, 1984 and all other enabling powers hereby makes the following Order:-

1. Citation and Commencement

This Order shall be known as the "Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) (Hall Road District Centre) Amendment Traffic Regulation Order 2015" and shall come into effect on 1<sup>st</sup> day of September 015.

2. The City of Norwich (Southern Area) (Prohibition and Restriction of Waiting) (Consolidation) Order, 1982 (as amended) (hereinafter referred to as the 1982 Order") is amended as specified in Articles 3, 4 and 5 of this Order.
3. In Schedule 16 the reference to Hall Road is amended as specified in the Schedule 1 of this Order.
4. In Schedule 31 the reference to Hall Road is added as specified in the Schedule 2 of this Order
5. In Schedule 302 the reference to Hall Road is added as specified in the Schedule 3 of this Order.
6. Insofar as any provision of any previous Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.
