NORWICH CITY COUNCIL (SOUTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING) (CUNNINGHAM ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2011

The City Council of Norwich pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with the Norfolk County Council and in exercise of the powers of the Norfolk County Council under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following Order:-

1. Citation and Commencement

This Order may be cited as the Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) (Cunningham Road) Traffic Regulation Order 2011 and shall come into effect for all purposes on the 26th day of September 2011.

- 2. The Norwich City Council (Southern Area) (Prohibition and Restriction of Waiting) Consolidation Order 1982 (as amended) is amended as specified in Article 3 of this Order.
- 3. In Schedule 1 the references to Cunningham Road and Earlham Green Lane are added, the reference to Wilberforce Road is amended and the reference to George Fox Way is deleted as specified in Schedule 1 of this Order.

<u>Schedule 1</u> - No Waiting At Any Time

Cunningham Road - additional provision

Insert the following reference:-

Both sides

(i) from its junction Earlham Green Lane to a point 54 metres east of the eastern boundary line No.2 Cunningham Road

Earlham Green Lane – additional provision

Insert the following reference:-

West side

(i) from a point 10 metres north of the northern back of highway line of Cunningham Road to a point 10 metres south of the southern back of highway line of Cunningham Road

George Fox Way – amended provision

Delete all references to George Fox Way

Wilberforce Road - amended provisions

Delete the following references:-

- (i) the east side from a point opposite and 20 metres north of the centre line of the access road into the University Village to a point opposite and 28 metres south of that centre line
- (ii) the east side from a point opposite the centre line of Robson Road at its southern junction with Wilberforce Road to a point opposite and 32 metres south of the centre line of George Fox Way
- (iii) the east side from a point opposite the northern building line of No. 13 Village Close for a distance of 20 metres in a southerly direction
- (iv) the east side from its junction with Earlham Road to the northern boundary of No. 99 Friends Road
- (v) the west side from a point 10 metres south of the boundary of No. 1 Robson Road and No.1b Wilberforce Road to a point 21 metres south of the southern back of highway line of Bridge Farm Lane
- (vi) the west side from its junction with Earlham Road to a point opposite the boundary of Nos. 2 and 3 Augustus Hare Drive

Insert the following references:-

- (i) the east side from a point opposite the centre line of Robson Road at its southern junction with Wilberforce Road to its junction with Rockingham Road
- (ii) the west side from a point 10 metres south of the boundary of No. 1 Robson Road and No.1b Wilberforce Road to its junction with Bridge Farm Lane
