NORWICH CITY COUNCIL (UNIVERSITY AREA CONTROLLED PARKING ZONE) (WEST EARLHAM AREA)

AMENDMENT TRAFFIC REGULATION ORDER 2011

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (University Area Controlled Parking Zone) (West Earlham Area) Amendment Traffic Regulation Order 2011 and shall come into effect for all purposes on the 26th September 2011.

- 2. The Norwich City Council (University Area Controlled Parking Zone) Traffic Regulation Order 2004 (hereinafter called "the 2004 Order") is amended as specified in Articles 3, 4, 5, 6, 7, 8 and 9 of this Order.
- In Schedule 1 the references to Augustus Hare Drive, Edgeworth Road, Hankin Court, Mottram Close, Priscilla Road, Rachel Close, Richenda Close, and Sarah Williman Close are added. Also in Schedule 1 the references to Cunningham Road, Friends Road and Scarnell Road are amended. These additions and amendments to Schedule 1 are specified in Schedule 1 of this Order.
- 4. The following paragraph is added as Article 3 (2) b:-

"No person shall cause or permit any vehicle to wait in the lengths of road mentioned in schedule 2 at any time."

- 5. In Schedule 2 the references to Edgeworth Road, George Fox Way, Mottram Close, Priscilla Close, Rachel Close, Richenda Close and Wilberforce Road are added. Also in Schedule 2 the references to Cunningham Road, Friends Road and Scarnell Road are amended. These additions and amendments to Schedule 2 are specified in Schedule 2 of this Order.
- 6. In Schedule 74 the references to Augustus Hare Drive, Cunningham Road, George Fox Way, Hankin Court, Mottram Close, Priscilla Road, Rachel Close, Richenda Close, Sarah Williman Close and Scarnell Road are added. Also in Schedule 74 the references to Friends Road are amended. These additions and amendments to Schedule 74 are specified in Schedule 3 of this Order.
- 7. In Schedule 75 the reference to Cunningham Road is added as specified in Schedule 4 of this Order.

- 8. The following paragraph is added as Article 4 (4):-
 - "A person may cause or permit a vehicle to wait in the streets or part of streets mentioned in Schedule 113 of this Order At Any Time."
- 9. Reference to Wilberforce Road in Schedule 113 is added as specified in Schedule 5 of this Order.
