THE OLDHAM - LEES AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & LOADING AMENDMENT No 28 ORDER 2025

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- 1. This Order made on 12th June 2025 shall come into operation on 19th June 2025 and may be cited as the Oldham Lees Area Consolidation Order Prohibition of Waiting & Loading Amendment No 28 Order 2025.
- 2. The Oldham Lees Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting and loading restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and the waiting and loading restrictions detailed in the Second Schedule below are included in the Principal Order at Part I Schedule I from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
