#### **THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & RESIDENTS' PARKING PLACES AMENDMENT No 220 ORDER 2022**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 12<sup>th</sup> December 2022 shall come into operation on 19<sup>th</sup> December 2022 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting & Residents' Parking Places Amendment No 220 Order 2022
2. The Oldham – Oldham Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and the Residents' Parking Places detailed in the Second Schedule below are introduced into Part II Schedule 3a of the Principal Order from the date of this Order.
3. This Order shall be construed as one with the Principal Order.

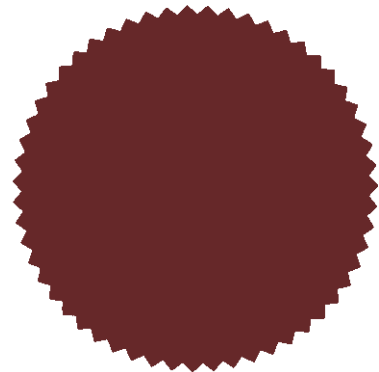
