**THE OLDHAM - CROMPTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING &  
PERMITTED PARKING AMENDMENT No 63 ORDER 2021**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 18<sup>th</sup> June 2021 shall come into operation on 25<sup>th</sup> June 2021 and may be cited as the Oldham – Crompton Area Consolidation Order Prohibition of Waiting & Permitted Parking Amendment No 63 Order 2021
  
2. The Oldham Area Crompton Area Consolidation Order 2003 the "Principal Order" shall have effect as though the waiting restrictions detailed in the First Schedule below are included in the Principal Order at Part 1 Schedule 1 and the permitted parking detailed in the Second Schedule below are included in the Principal Order at Part 1 Schedule II from the date of this Order
  
3. This Order shall be construed as one with the Principal Order.

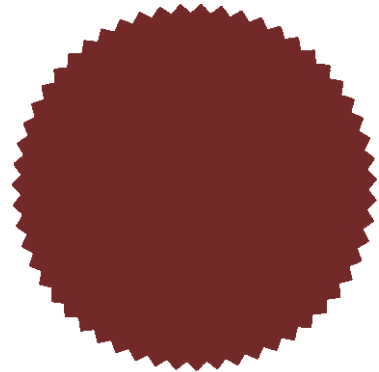
