ROAD TRAFFIC REGULATION ACT 1984

**THE OLDHAM BURNLEY LANE & BIRCH AVENUE CHADDERTON PROHIBITION OF WAITING
EXPERIMENTAL ORDER 2022**

The Oldham Borough Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 21st February 2022 shall come into operation on 28th February 2022 and may be cited as the Oldham Burnley Lane & Birch Avenue Chadderton Prohibition of Waiting Experimental Order 2022 and will continue in force until 28th August 2024
2. The Director of Environmental Services for Oldham Borough Council may, if that officer considers it essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, and after consulting with the Chief Officer of Police, modify or suspend this Order, or any provision thereof, at any time.
3. The Oldham Chadderton Area Consolidation Order 2003 the "Principal Order" shall have effect as though the items detailed in the First Schedule below are deleted from the Principal Order at Part I Schedule I and the items detailed in the Second Schedule below are included in the Principal Order at Part I Schedule I from the date of this Order until 28th August 2024
4. This Order shall be construed as one with the Principal Order.
