

**ROAD TRAFFIC REGULATION ACT 1984**

**THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER EXPERIMENTAL PROHIBITION OF WAITING & PARKING PLACES (ON STREET) ORDER 2018**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2), 4(2), 9, 32, 35, 45 & 46 of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 27<sup>th</sup> March 2018 shall come into operation on 3<sup>rd</sup> April 2018 and may be cited as the Oldham – Oldham Area Consolidation Order Experimental Prohibition of Waiting Order & Parking Places (On Street) 2018 and will continue in force until 2<sup>nd</sup> October 2019
2. The Oldham – Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the “Principal Order”) shall have effect as though the Waiting Restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and the Parking Places (ON Street) detailed in the Second Schedule below are deleted from the Principal Order at Part II Schedule 6 and the Waiting Restrictions detailed in the Third Schedule below are inserted in the Principal Order at Part 1 Schedule 1 and the Parking Places (On Street) detailed in the Fourth Schedule below are inserted in the Principal Order at Part II Schedule 6 for the for the period of this Order
3. This Order shall be construed as one with the Principal Order for the period of this Order.
