**THE OLDHAM – FAILSWORTH AREA CONSOLIDATION ORDER PROHIBITION OF
WAITING, LOADING & PARKING PLACES
AMENDMENT No 48 ORDER 2018**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 16th February 2018 shall come into operation on 23rd February 2018 and may be cited as the Oldham – Failsworth Area Consolidation Order Prohibition of Waiting, Loading & Parking Places Amendment No 48 Order 2018
2. The Oldham Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting and loading restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting and loading restrictions detailed in the Second Schedule below and the Parking Places (Specified Classes of Vehicle) detailed in the Third Schedule below are deleted from the Principal Order at Part II Schedule 4 and replaced with the Parking Places (Specified Classes of Vehicle) detailed in the Fourth Schedule below from the date of this Order
3. This Order shall be construed as one with the Principal Order.
