ROAD TRAFFIC REGULATION ACT 1984

**THE OLDHAM – FOXDENTON LANE/LYNDHURST AVENUE/HORSESHOE LANE
7.5 TONNE WEIGHT RESTRICTION ORDER 2020**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 10th December 2020 shall come into operation on 14th December 2020 and may be cited as the Oldham – Foxdenton Lane/Lyndhurst Avenue/Horseshoe Lane 7.5 Tonne Weight Restriction Order 2020.
2. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
4. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any vehicle to proceed (except for loading or unloading) in the lengths of road specified in the Schedule to this Order.
5. Nothing in Article 4 shall render it unlawful to cause or permit any vehicle to proceed in the length of road referred to therein where that vehicle is being used:-
 - (a) for police, fire brigade or ambulance purposes;
 - (b) for the maintenance, improvement or reconstruction of the length of road or any other adjacent length of road or the laying, erection, alteration or repair in, or in land adjacent to, the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (c) if it cannot conveniently be used for such purpose in any other road, in the service of a local authority or a water authority in pursuance of statutory powers or duties.

6. The Oldham – Foxdenton Lane/Grimshaw Lane (Chadderton) Weight Restriction Order 200 shall be revoked in its entirety from the date of this Order

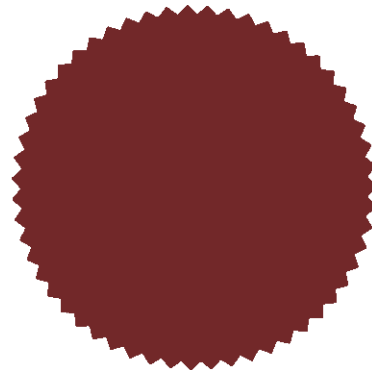
