ROAD TRAFFIC REGULATION ACT 1984

**THE OLDHAM – HEY WITH ZION SCHOOL & ST EDWARDS SCHOOL EXPERIMENTAL
PROHIBITION OF MOTOR VEHICLES ORDER 2024**

The Oldham Borough Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 2nd September 2024 shall come into operation on 9th September 2024 and may be cited as the Oldham – Hey with Zion School & St Edwards School Experimental Prohibition of Motor Vehicles Order 2024 and shall remain in force until 9th March 2026
2. The Director of Environmental Services for Oldham Borough Council may, if that officer considers it essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, and after consulting with the Chief Officer of Police, modify or suspend this Order, or any provision thereof, at any time
3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
5. Save as provided in Article 6 no person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any motor vehicle to proceed in the lengths of road and during the times specified in the Schedule to this Order.
6. Nothing in Article 5 shall render it unlawful to cause or permit any motor vehicle to proceed in the length of road referred to therein where that vehicle is being used for police, fire brigade or ambulance purposes

SCHEDULE

Prohibition of Motor Vehicles

Monday to Friday 8.15am to 9.15am and 2.45pm to 3.45pm

Lengths of Road	Exemptions
Medlock Way - from a point 35 metres west of its junction with Beckett Street, Westbound for its entire length. Further Hey Close - for its entire length. Rowland Way – for its entire length	Fire, Police & Ambulance Emergency Vehicles Blue Badge Holders Permit Holders

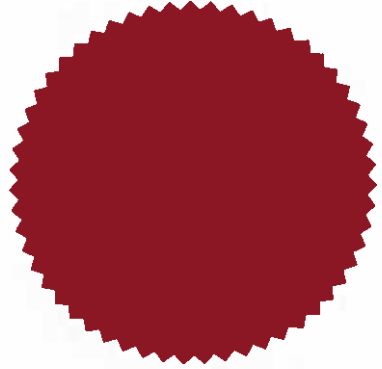
Sunfield Way – for its entire length
Little Oak Close – for its entire length
