ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM LYDIA BECKER WAY CHADDERTON PROHIBITION OF STOPPING (24 HOUR CLEARWAY) ORDER 2021

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2), 2(3) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order made on 18th June 2021 may be cited as the Oldham Lydia Becker Way Chadderton Prohibition of Stopping (24 House Clearway) Order 2021 and shall come into operation on 25th June 2021
- 2. Save as provided in Articles 3 and 4, no person shall cause or permit any vehicle to stop or wait at any time or to load or unload at any time in the lengths of road specified in the Schedule to this Order
- 3. Nothing in Article 2 shall apply to the following vehicles:
 - (a) any vehicle which is, if it cannot be used for such purposes in any other road, being used or is to be used in the service of a Local Authority in pursuance of statutory powers or duties.
 - (b) any vehicle which is, if it cannot be used for such purposes in any other length of road, being used in connection the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near any of the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus.
 - (c) any vehicle, which is, if it cannot be used for such purposes in any other length of road, being used in connection with the removal of any obstruction to traffic
 - (d) any vehicle, which is, if it cannot be used for such purposes in any other length of road, being used in connection with any building operation or demolition.
 - (e) any vehicle waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident.
 - (f) any vehicle waiting for the purpose of facilitating the movement of traffic or promoting its safety.
- 4 Nothing in Articles 2 and 3 shall apply to any vehicle being used for Police, Fire Brigade or Ambulance purposes where the restriction would be likely to hinder the use of that vehicle in fulfilling that purpose and which is taking all reasonable precautions and nothing in Articles 2 and 3 shall apply to anything done upon the direction of or with the permission of a police constable in uniform, a police community support officer in uniform or a civil enforcement officer in uniform.
